RE: New Pharmacy Benefit Manager - Sav-Rx – Effective January 1, 2022

### **IMPORTANT ANNOUNCEMENT**

The Board of Trustees is pleased to announce a new Pharmacy Benefit Manager, effective January 1, 2022. Sav-Rx will replace CVS/Caremark to provide pharmacy benefit services for you and your covered dependents.

#### **What Happens Next**

In the coming weeks, you will receive a Welcome Packet along with a new Prescription Identification Card, which will include prescription processing information from Sav-Rx Prescription Services. This Card, like your Driver's License, should be kept with you always. **Please do not throw this information away.**

You may also receive a notification letter if this change will impact a current prescription taken by you or your dependents and the next steps that may be necessary. Once you receive your new Prescription ID Card, you will need to notify your current retail pharmacy that Sav-Rx will serve as the new Pharmacy Benefit Manager *after* January 1, 2022 so that you will be able to obtain your prescription(s) in a timely manner. If the pharmacy does not have this updated information, your prescription(s) could be delayed.

Your current valid mail order prescription(s) may be transferred to the Sav-Rx Mail Order Pharmacy after January 1, 2022. You will be able to request your mail order refills directly from Sav-Rx after January 1, 2022.
